Sales Tax Rules and Regulations - Resale Certificates

Under "description of property to be purchased" there may appear: 1. Either an itemized list of the particular property to be purchased for resale, or 2. A general description of the kind of property to be purchased for resale. This certificate is good until revoked in writing.
